

# IDAHO PUBLIC UTILITIES COMMISSION

## MINUTES OF DECISION MEETING

**April 27, 2021 – 1:30 P.M.**

In attendance was Commissioner Paul Kjellander, Commissioner Kristine Raper and Commissioner Eric Anderson. Commissioner Kjellander called the meeting to order.

The first order of business was **APPROVAL OF MINUTES FROM THE PREVIOUS MEETING** on April 19, 2021. The Commission voted unanimously to approve the minutes as written.

**2. Action Item: Matt Hunter's April 21, 2021 Decision Memorandum re: In the Matter of Idaho Power Company's Application for Approval of the Capacity Deficiency to be Utilized for Avoided Cost Calculations; Case No. IPC-E-21-09.**
