

# **IDAHO PUBLIC UTILITIES COMMISSION**

## **MINUTES OF DECISION MEETING**

### **SUBJECT TO APPROVAL**

**April 23rd, 2025 – 1:30 p.m.**

In attendance was Commissioner Lodge, Commissioner John R. Hammond, Jr. and Commissioner Hardie. Commissioner Lodge called the meeting to order.

The first order of business was the **ADOPTION OF THE PROPOSED AMENDED AGENDA** for April 23<sup>rd</sup>, 2025.

Commissioner Lodge made a motion, under Idaho Code § 74-204, to amend the agenda, adding Action Items No. 9 and 10 to the **CONSENT AGENDA**, Action Item No. 9: Adam Triplett's April 23, 2025, Decision Memorandum re: In the Matter of the Application of Rocky Mountain Power for a Deferred Accounting Order Related to Chehalis Compliance Costs; Case No. PAC-E-25-05. And Action Item No. 10: Erika Melanson's April 23, 2025, Decision Memorandum re: In the Matter of Idaho Power Company's Application for Its First Annual Update to the Export Credit Rate for Non-Legacy On-Site Generation Customers from June 1, 2025 through May 31, 2026, In Compliance with Order No. 36048; Case No. IPC-E-25-15.. A vote was taken on the motion and it carried unanimously.

Commissioner Hardie disclosed conflicts of interest with item no. 8, PLW-W-24-02, due to previous involvement in his previous role as a Deputy Attorney General and abstained from making decisions on those items.

Commissioner Lodge made a motion to approve Staff's recommendations for Items 2 through 7, 9 and 10 under the Consent Agenda. A full commission vote was taken on the motion, and it carried unanimously.

Commissioner Lodge made a motion for himself and Commissioner Hammond to approve Staff's recommendations for Item no. 8 under the Consent Agenda. A vote was taken on the motion, and it carried unanimously.

Commissioner Hammond requested an expeditious issuance of the order and press release for PLW-W-24-02 due to the new hearing date and comment deadline.

The next order of business was **MATTERS IN PROGRESS:**

**11. Action Item: Johan E. Kalala-Kasanda's April 23, 2025, Decision Memorandum re: 2024 Idaho Telephone Service Assistance Program ("ITSAP") Annual Report; Case No. GNR-T-25-04.**

Mr. Kalala-Kasanda presented the memorandum regarding the ITSAP Annual Report providing the commission with staff's report. After reviewing the Administrators report, staff determined that the commission's action of reinstating the session rated proved to be very beneficial to the program and has stabilized the funds of the program. As a result of the reinstatement the case balance at the end of 2024 was \$633,000. Additionally, the positive outcome prompted companies who were not reporting access lines to the Administrator to begin doing so resulting in more revenues for the fund. Based on the Administrators judgment this change should reduce the social rate from 0.05 to 0.03, at least for this year.

Commissioner Lodge made a motion to accept the 2024 ITSAP Annual Report and adopt the Administrator's 2025 budget. Additionally, directing all companies to report access lines counts to the Administrator. A vote was taken on the motion, and it carried unanimously.
