

# **IDAHO PUBLIC UTILITIES COMMISSION**

## **MINUTES OF DECISION MEETING**

### **SUBJECT TO APPROVAL**

**September 2nd, 2025 – 1:30 p.m.**

In attendance was Commissioner Lodge, Commissioner John R. Hammond, Jr. and Commissioner Hardie. Commissioner Lodge called the meeting to order.

The first order of business was the **ADOPTION OF THE PROPOSED AMENDED AGENDA** for September 2<sup>nd</sup>, 2025.

Commissioner Lodge made a motion, under Idaho Code § 74-204, to amend the agenda, Erika Melanson's September 2, 2025, Decision Memorandum re: In the Matter of Rocky Mountain Power's Application to Increase the BPA REP Credit Effective October 2025 Through September 2028; Case No. PAC-E-25-17. A vote was taken on the motion and it carried unanimously.
