On February 28, 2020, Avista Corporation ("Avista") filed its amended 2019/2020 Electric Integrated Resource Plan ("2020 Electric IRP").

On March 25, 2020, the Commission issued a Notice of 2020 Electric Integrated Resource Plan and Notice of Intervention Deadline. Order No. 34609. Idaho Conservation League ("ICL"), Avista, and Commission Staff are parties to the case.

On May 13, 2020, the Commission issued a Notice of Modified Procedure establishing comment and reply comment deadlines.

## **BACKGROUND**

The Integrated Resource Plan ("IRP") is a biennial status report on the utility's ongoing and evolving plans to adequately and reliably serve its customers at the lowest system cost and least risk over the next 20 years. Avista develops its IRP through a public process involving customers, Commission Staff, the Northwest Power and Conservation Council, consumer advocates, academics, environmental groups, utility peers, government agencies and other interested parties. Avista submits its IRP to the Commission for acknowledgment. Commission acknowledgment of the IRP does not mean the Commission approves of any specific conclusions or results in the Company's IRP but rather acknowledges that the Company has adequately addressed the matters required by the Commission's prior orders. *See* Order Nos. 22299, 25260.
