On August 1, 2024, Avista Corporation, doing business as Avista Utilities ("Company"), filed two applications with the Idaho Public Utilities Commission ("Commission") requesting prudence determinations of its 2022-2023 Electric and Natural Gas Energy Efficiency Expenses (collectively "Applications").

The Company requests an order designating its electric energy efficiency expenditures from January 1, 2022, through December 31, 2023, funded through the Company's Schedule 91 Energy Efficiency Rider Adjustment in the amount of \$15,972,882, as prudently incurred.

The Company also requests an order designating its natural gas energy efficiency expenditures from January 1, 2022, through December 31, 2023, funded through the Company's Schedule 191 Energy Efficiency Rider Adjustment in the amount of \$4,149,757, as prudently incurred.

On September 6, 2024, the Commission issued a Notice of Applications and Notice of Intervention Deadline. Order No. 36303. No parties intervened. On October 2, 2024, a Notice of Parties was issued.

Service between parties should continue to be accomplished electronically when possible. However, voluminous discovery-related documents may be filed and served on CD-ROM or a USB flash drive.
