On March 31, 2025, Idaho Public Utilities Commission Staff ("Staff") filed an application ("Application") with the Idaho Public Utilities Commission ("Commission") requesting that the Commission modify its Request for Proposal ("RFP") oversight process. Application at 1.

NOTICE OF APPLICATION

YOU ARE HEREBY NOTIFIED that Staff requests that the Commission: (1) rescind Commission Order No. 32745, which requires Idaho Power Company to comply with Oregon's RFP guidelines; and (2) direct each investor-owned electric utility¹ ("Utilities") to apply for and receive Commission approval for each new RFP prior to issuing it for the acquisition of large supply-side resources. *Id.* at 2. Staff represents that each new RFP application should include the proposed RFP, a written explanation of the process that will be used to narrow the bid pool and select the final resources and other supporting documents. *Id.*

YOU ARE FURTHER NOTIFIED that Staff represents that if its Application is approved, Staff, interested parties, and the Commission will be able to review how Utilities will conduct each solicitation and selection to ensure the least-cost and least-risk resources are selected based on the specific circumstances and needs of the Utility's system prior to soliciting bids. *Id*.

YOU ARE FURTHER NOTIFIED that the Application and all supporting documents have been filed with the Commission and are available for public inspection during regular business hours at the Commission's office. These documents are also available on the Commission's website at www.puc.idaho.gov. Click on the "ELECTRIC" icon, select "Open Cases," and click on the case number as shown on the front of this document.

YOU ARE FURTHER NOTIFIED that once the Notice of Parties is issued, Commission Staff ("Staff") will informally confer with the parties to discuss a schedule to process this case and other issues as may be raised by the parties.
