My situation is such that my savings is slowly bleeding out because my minimum cost of living is 350 dollars a month more than what is coming in. When I lost my job my income dropped by approximately a third and everything has gone up to almost double. Gas, food, my housing cost, electricity, insurance, everything! Every bulb in my house is a spiral and I just don't see where I can cut back any more. Another rate hike is probably going to be the straw that breaks my back. I am begging you please don't raise the cost of my electricity again.
