I know Idaho Power has requested a rate increase and hope this does not happen. With the economy the way it is, people unemployed and those on fixed incomes can barely pay their power bills as it is. With the new meters, the Energy Charge over 2000 kWh, Service Charge and the Energy Efficiency Services has increased the consumer cost substantially. Idaho Power can makes some cuts even if it's putting their clerical staff on part time or decrease the Executive salaries by half!
