Comment: I am a current residential power generator and I understand that the power I generate from my solar panels goes on to the power grid and I am under the Net Zero program with Idaho Power.

My concern is with the new rate changes for reimbursement from a Net Zero to a return of 8.7 cents/kilowatt hour down to 4.4 cents/kilowatt hour will not continue my Net Zero. When I say Net Zero I am still paying a \$5.20/month connection fee to be connected to the grid.

Here are my concerns:

1) Will the current customers on the Net Zero program with Idaho Power have a permanent grandfather clause so that no rate changes occur?

2) I bought my solar panels to have a fixed cost for electricity as I am nearing retirement and will have a fixed budget. How does Idaho Power propose that I can budget or plan for retirement if I have to worry about ever increasing costs when my retirement income will be fixed?

What I do not see from Idaho Power other than another rate hike is information specifically showing why my free power to Idaho Power cannot be kept at the current Net Zero rate:

1) The power generation helps offset Idaho Power's purchase of power during peak hours specifically during the summer when air-conditioners are running.

2) If more people elect to place solar on their houses what are the net affects? i.e. cost of Idaho Power not having to building more generation plants or buying power from the open market.

3) If there is too much power on the grid because of the individual generation why is it that Idaho Power cannot sell this excess on the open market? I am pretty sure Idaho Power can predict any excess power generation based on the current weather conditions.

4) Why doesn't Idaho Power create power storage facilities if there is excess power generation? I would imagine this would have less environmental impact than building power generating facilities. What are these costs compared to building power generating facilities? What is the true fixed costs of the power grid.

5) Idaho Power should encourage individual power generation because solar and wind are green sources and are bought and maintained by the individual homeowner (no expense to Idaho Power for either the power generation equipment or the electricity generated).

Any feedback and schedules for meetings on this issue within Canyon County would be greatly appreciated.

Comment: I had a solar power electricity generating system installed on my home and it began operation in March, 2019. I paid for the system and its' installation in cash, at the cost of approximately \$27,000.

If I understand the letter I recently received from Idaho Power (concerning a settlement agreement regarding changes to the compensation schedule for residential and small general service contractors who generate power on their own site) the proposal might result in the compensation I currently receive for on-site generated power being more than halved ultimately. If I had known such a settlement was pending I would have objected to it in the strongest terms. I was unaware that such talks were underway and that an understanding of my expectations was subject to a negative change. I write you now to ask you to consider that such a compensation settlement is the equivalent of unlawful seizure of financial gain reasonably anticipated by an Idaho Power customer.

If some form of grandfather arrangement is possible to shield me from the losses I would suffer under the settlement agreement I strongly urge that a customer like me be grandfathered so that the promised agreement of solar powered electricity sent to Idaho Power be remunerated at the full retail cost level.

I am willing to share my concerns directly if some manner of communication between members of the IPUC and myself can be put in place.
