Dear Governor Little,

I am writing you regarding the settlement agreement between Idaho Power and the Staff of the Idaho Public Utilities Commission (IPUC) detailing changes to the compensation structure for residential customers with on-site (rooftop) power generation. There has been a fair amount of news on this topic as well as public phone and in-person hearings. I won't go into the detail of that settlement as I'm sure you are fully aware of its provisions and what it will do to the solar industry in Idaho, the environment, and the residential customers with roof-top solar systems.

Rather, the purpose of this letter is to expose facts I uncovered while researching the settlement. I uncovered a history of exceptional generosity from IPUC to Idaho Power that does not appear to be in the public's best interest. What I was unable to determine was the motivation behind this exceptional generosity at the direct expense of Idaho Power customers.

Idaho Power's parent company, IDACORP's 2018 revenues were 1.4 billion dollars and its operating profit was 297 million dollars. Earnings growth was 6.7%, net income growth was 6.8%, and dividend growth was 6.8% in 2018. Over 125 million dollars of excess cash generated in 2018 was paid to shareholders in the form of dividends and stock buy-backs. In addition to the dividend payments, shareholders have also enjoyed the stock appreciating from \$62/share to over \$104/share over the past five years. The chairman and the president begin their letter to shareholders with, "IDACORP enjoyed another incredible year of accomplishment in 2018, punctuated by our 11th consecutive year of earnings growth — a feat that is unprecedented for our company and unique among investor-owned utilities during that period." Furthermore, just last month IDACORP announced yet another increase in its shareholder dividends. These dividends are the result of the consumers paying higher power rates than they should. Clearly, IPUC has been exceptionally generous to Idaho Power over the past 11 years at the expense of the consumer. Or, IPUC has abdicated its responsibility to the power consuming public.

Idaho Power's CEO was compensated \$4.5 million dollars in fiscal year 2019. This is up 80% from \$2.5M just four years earlier in 2015. Additionally, there are several other Idaho Power executives compensated in the millions of dollars per year. The beneficiaries of IPUC's exceptional generosity are clear, and they do not include Idaho Power's customers or its roof-top solar power generators. What is not clear is what IPUC is getting in return for this openhandedness to Idaho Power at the public's expense. I urge you to uncover the answer to this question and to provide transparency to Idaho citizens.

Because Idaho citizens cannot rely on IPUC to protect their interests, I am respectfully asking you to step in on behalf of your constituents and stop Idaho Power's use of its monopolistic power and greed, which has been left un-checked for many years by IPUC. If you disagree with the information provided above, please respond with your thoughts to this letter so I may better understand how IPUC is protecting the consuming public from Idaho Power's monopolistic powers and greed.

As a side note, it's also worth mentioning the risk the solar settlement mentioned in the first paragraph is exposing the Idaho tax payers to. If not exempted from the settlement, existing rooftop solar power generators will almost certainly file a class-action lawsuit against IPUC. Based on my knowledge of the settlement and the facts stated in this letter, IPUC, even with legal assistance from Idaho Power, will find it difficult to defend its actions and the state risks losing millions of dollars.
