Dear Ms. Hanian:

Subsequent to the filing of Idaho Power Company's ("Idaho Power" or "Company") 2019 IRP, the Company has identified the need to perform supplemental analysis related to the capacity expansion modeling approach utilized for the first time in the 2019 analysis in order to confirm the accuracy of the IRP's conclusions and findings. Idaho Power anticipates that the required supplemental analysis will be substantial and time consuming. At this time, the Company estimates that this additional work can be completed—and filed for Idaho Public Utilities Commission ("Commission") and party review following consultation with its IRP Advisory Council—by October 31, 2019. For these reasons, Idaho Power suggests that the Commission refrain from setting a schedule in this docket until after the filing is made.

The Company apologizes for the delay but believes that the supplemental analysis is required to ensure the accuracy of the IRP's findings, and will result in a sound basis for the Company's continued resource planning efforts.
