On December 11, 2020, Idaho Power Company asked the Commission to approve or reject an amendment to its Energy Sales Agreement ("ESA") with ID Solar 1, LLC ("ID Solar 1"). ID Solar 1 is a qualifying facility ("QF") under the Public Utility Regulatory Policies Act of 1978 ("PURPA").

The Commission now sets deadlines for interested persons to comment on the Application, and for Idaho Power to reply.

NOTICE OF APPLICATION

YOU ARE HEREBY NOTIFIED that the proposed amendment would allow ID Solar 1 to adjust its monthly estimated net energy amount by the 25th day of each month, whereas the current provision requires ID Solar 1 to provide its monthly estimated net energy amount one month in advance.

YOU ARE FURTHER NOTIFIED that the proposed amendment is like other amendments recently approved by the Commission.

YOU ARE FURTHER NOTIFIED that in July 2014, Idaho Power entered an ESA to buy energy and capacity from the QF. Order No. 33180, IPC-E-14-20. The QF was later transferred from Boise City Solar, LLC to Idaho Solar 1. Order No. 33596, IPC-E-16-20.

YOU ARE FURTHER NOTIFIED that the Application is available for public inspection during regular business hours at the Commission's office. These documents are also available on the Commission's web site at www.puc.idaho.gov. Click on the "ELECTRIC" icon, select "Open Cases," and click on the case number as shown on the front of this document.
