The Industrial Customers of Idaho Power (“ICIP”) petitioned to intervene in this case on June 10, 2021, and Idaho Hydroelectric Power Producers Trust, d/b/a IdaHydro (“IdaHydro”) petitioned to intervene in this case on June 14, 2021. Both petitions were made pursuant to Rules of Procedure 71 through 75 of the Idaho Public Utilities Commission, IDAPA 31.01.01.071-.075.

**FINDINGS OF FACT**

We find that no party timely opposed these Petitions to Intervene.


