Currently, our electric rates are designed to cover Bridgers costs by 2034. To match the repayment with the accelerated retirement of Bridger, Idaho Power wants to collect about \$27 million additional dollars each year through 2030. We can reduce this amount with your help. Part of this total includes Idaho Powers cost to borrow money. They claim they need to charge us 7.8% interest. But, that is a choice they are making to benefit their shareholders. Instead, Idaho Power could choose to use modern financial tools to reduce this interest rate to closer to 5%. This would save us millions each year while still closing coal quickly. Continuing to allow solar credits from private systems on their grid is another great way to save generating costs and help restore salmon. Encouraging and expanding energy credits for solar and on demand water heaters and heat pumps is another way to cut costs and help conservation efforts. Tell Idaho Power to choose customers over shareholders and save money while closing coal and being good natural resource stewards. Idaho Public Utilities Commission should certainly choose customers over shareholders and save money while closing coal and being good natural resource stewards."
