Comment: "Our company is currently in dispute with Idaho Power regarding the new Schedule 20 requirements. We are a company that utilizes waste heat from computing processes for cryptomining and other energy-intensive calculations and data server requirements. We understand and support the practice of curtailing, this applies to cryptomining facilities across the world, however the terms of Schedule 20 would be costprohibitive to our business model. We would have to maintain at least some level of minimal operations to keep our greenhouse facilities heated and cooled all year round. Additionally, the cost/kWh information we were receiving did not seem fair to all market sectors. If we are installing our technology on an agricultural industrial site, why should we be charged more than that facility is currently paying for their power purchase agreement? Three of our four partners are Idaho natives and we have a strong love and affinity for our state and we just want the opportunity to bring something new and exciting to share and grow for everyone.
