 Micron receives electric utility services from Idaho Power Company ("Idaho Power") as a Special Contract customer. Micron is Idaho Power's single largest customer. In this

proceeding, Micron seeks to complete the study review phase for a comprehensive study of the costs and benefits of on-site generation. As a large customer, Micron has an interest in insuring

compensation paid to customers with on-site generation is just and reasonable and does not create

inappropriate cost shifts to customers without on-site generation. Micron therefore supports Idaho

Power's efforts to conduct a transparent and comprehensive study of these issues. Micron was

also an active participant in Case Nos. IPC-E-18-15 and IPC-E-21-21 in which the Commission

directed Idaho Power to conduct the study that is the subject to this proceeding. Therefore, Micron has a direct and substantial interest in this proceeding because Idaho Power's application may affect its rates for electric service.
