On January 9, 2023, Idaho Power Company ("Company") applied for an order granting a Certificate of Public Convenience and Necessity for the purpose of constructing "a 300-mile long, overhead 500-kV high voltage line" ("Application"). Application at 1. The transmission line would be between a proposed substation near Boardman, Oregon, and the Hemingway Substation in southwest Idaho. The Company asserted the transmission line is crucial to meeting a 2026 capacity deficit. The Company hoped to begin construction in the summer of 2023 and requested a final order be issued by June 30, 2023.

On February 1, 2023, the Commission issued a Notice of Application and Notice of Intervention Deadline. Order No. 35674. The Idaho Irrigation Pumpers Association, Inc., Idaho Industrial Customers of Idaho Power, City of Boise City, Micron Technology, Inc., and Idaho Conservation League intervened. Order Nos. 35685 and 35695.

On April 10, 2023, the Commission issued a Notice of Modified Procedure and Notice of Public Workshop.
