ERRATA TO THE DIRECT TESTIMONY OF JARED L. ELLSWORTH

Idaho Power Company ("Idaho Power" or "Company") hereby respectfully submits to the Idaho Public Utilities Commission ("Commission") this Errata to the Direct Testimony of Jared L. Ellsworth ("Ellsworth Testimony") in support of the Company's Application to implement changes to its on-site, self-generation tariffs in accordance with

ERRATA TO THE DIRECT TESTIMONY OF JARED L. ELLSWORTH - 1

Order No. 35631,¹ to make the following changes to ensure accuracy, consistency, and clarity of the record as follows.

1. The Company recently became aware of a discrepancy in the Ellsworth Testimony filed on May 1, 2023, regarding the source for one of the inputs used to determine the avoided generation capacity component of the Export Credit Rate ("ECR").

2. More specifically, in describing the resource the Company proposes be utilized as a proxy resource in determining the avoided cost of a generation resource, the

Ellsworth Testimony states on page 16 (lines 10-13):

The Company proposes to rely on the levelized fixed cost associated with the least-cost dispatchable resource from the Company's most recently acknowledged [Integrated Resource Plan]. In the 2021 IRP, that was a simple-cycle combustion turbine ("SCCT")...

3. While the current value of the levelized cost of the avoided resource would be based on the 2021 IRP, which does happen to be the Company's most recently acknowledged Integrated Resource Plan ("IRP"), the statement is not reflective of the Company's proposed timing for updating this input generally (i.e. based on the most recently *filed* IRP).

4. As described in the Direct Testimony of Grant T. Anderson ("Anderson Testimony"), the Company is proposing that those ECR inputs that are informed by the Company's IRP be set/updated at its filing, not upon acknowledgment.²

5. Though not material to the Company's request in this proceeding, for the

sake of consistency and clarity of the record the Company provides the following

substitution to incorporate within Ellsworth Testimony:

• On page 16, in the answer provided on lines 10 through 13, replace the word "acknowledged" on line 12 with "filed", *to wit*. "The Company proposes to rely on the levelized fixed cost associated with the least-cost dispatchable resource from the Company's most recently acknowledged filed IRP . . ."

This update does not change anything else about the Application or the Ellsworth Testimony.
