COMES NOW, Idaho Power Company ("Idaho Power" or "Company") and, pursuant to Idaho Public Utilities Commission's ("Commission") Rule of Procedure 203, and the Notice of Modified Procedure, Order No. 36065, hereby respectfully submits these Reply Comments in response to Comments of the Commission Staff ("Staff") in this case dated February 22, 2024.

Idaho Power appreciates Staff's thorough review and assessment of the Company's Annual Compliance filing to update the Substation Allowance under Schedule 19, Large Power Service. The Company agrees with Staff's proposed corrected Schedule 19 Substation Allowance of \$71,052 per MW.

Therefore, the Company respectfully requests the Commission issue an order: (1) approving the Schedule 19 Substation Allowance of \$71,052 per MW with an effective date of March 15, 2024, and (2) directing it to submit a corrected tariff sheet for approval.
