2. Micron receives electric utility services from Idaho Power Company ("Idaho Power") and is Idaho Power's single largest customer. Micron is also an Idaho Power Special Contract customer. Micron's revised Special Contract was approved by this Commission in Case No. IPC-E-22-06 along with Idaho Power's Power Purchase Agreement with Black Mesa Energy, LLC ("Black Mesa"), entered into in part to serve Micron under the Clean Energy Your Way ("CEYW") program. As discussed in Idaho Power's Application in this proceeding, Micron's Special Contract contains a provision that allows for another Idaho Power customer to purchase a share of Black Mesa electric generation.² In this proceeding, Idaho Power seeks Commission approval to effectuate that provision in Micron's Special Contract to enter into a new Renewable Construction Agreement between the City of Boise and Idaho Power utilizing a portion of Black Mesa electric generation.

- 3. This proceeding will impact Micron's Special Contract and the portion of Micron's electric load that is served from Black Mesa's output. Therefore, Micron has a direct and substantial interest in this proceeding.
