On February 13, 2025, Idaho Power Company ("Company") filed an application ("Application") with the Idaho Public Utilities Commission ("Commission") requesting an order authorizing the Company to defer newly identified costs associated with the Company's expanded wildfire mitigation efforts, as detailed in the Company's 2025 Wildfire Mitigation Plan ("WMP"). Application at 1.

On March 6, 2025, the Commission issued a Notice of Application and Notice of Intervention Deadline. Order No. 36494. No party intervened.

Persons interested in filing written comments must do so by June 17, 2025. Comments must be filed through the Commission's website or by e-mail unless computer access is unavailable. IT IS HEREBY ORDERED that the matter be processed by Modified Procedure. Persons interested in filing written comments must do so by June 17, 2025. The Company must file any reply comments by July 8, 2025.

IT IS FURTHER ORDERED that parties comply with Order No. 35375, issued April 21, 2022. Generally, all pleadings should be filed with the Commission electronically and will be deemed timely filed when received by the Commission Secretary. *See* Rule 14.02. Service between parties should continue to be accomplished electronically when possible. However, voluminous discovery-related documents may be filed and served on CD-ROM or a USB flash drive.
