PIIC is a coalition of Idaho companies that are industrial and large load customers of Rocky Mountain Power (“RMP” or the “Company”), and PIIC members pay RMP tariff and/or special contract rates for electric service. The Company’s request that the Commission approve \$21.2 million of deferred net power costs resulting in a 3.0% increase to Schedule 94 customers affects PIIC members. PIIC has a direct and substantial interest in this proceeding that will not be adequately represented by any other party. PIIC intends to participate in all respects of this proceeding and will not unreasonably broaden the issues, burden the record, or delay this proceeding.

4. Without the opportunity to intervene herein, PIIC would be without a manner or means of participating in the lawful determination of issues which will result in affecting the rates for electric service to the PIIC members.

WHEREFORE, PIIC respectfully requests that the Commission grant its petition to intervene with full party status in this proceeding and to appear and participate in all matters as may be necessary and appropriate; and to present evidence, call and examine witnesses, cross-examine witnesses, present argument, and to otherwise fully participate in the proceedings.
