

Bryan,

I have reviewed the request for indicative pricing and a PPA for the Fall River's Chester Hydro facility. Due to the size of the facility (1.84 MW) my understanding is this project would qualify for our standard pricing as listed on IPUCs website here: https://puc.idaho.gov/electric/PacifiCorp%20rates%2006-01-19.pdf; this looks to be a non-seasonal hydro project. Based on the information you have provided, the project would have a levelized price of \$54.12/MWh over a 20-year contract if PacifiCorp were to begin taking delivery in 2020 (as seen on page 3 of the referenced price list). Please note however that PacifiCorp plans to issue its 2019 IRP in the middle of this month which may impact the current pricing.

Prior to providing a draft PPA we will need to see a completed interconnection study from PacifiCorp transmission demonstrating that the project can be interconnected to our system on the timeline you have proposed for pricing. Your request indicated that you have begun the interconnection process, please keep us up to date with that progress so that we can move forward with a proposed PPA at the appropriate time. Have you received a queue number yet for the interconnection?
