Comment: "I reviewed the information from Rocky Mountain Power. The proposed rate changes penalize the user who is trying to conserve energy. The flat rate increases to a degree that a user must use about 837 kWh to break even. Usage under that amount results in an overall price increase. A quick calculation based on my March 2023 usage of 489 kWh shows that (considering the other charges remain the same) my costs will increase 4.1% the first year, 4.0% the second year, 3.8% the thrid year, 3.5% the forth year, and 3.8% the fifth year, for an overall increase of 20.65% in the 5 years. This is not a good plan and I hope it will be rejected."
