**SUBJECT: IN THE MATTER OF ROCKY MOUNTAIN POWER’S APPLICATION
FOR AUTHORITY TO IMPLEMENT THE RESIDENTIAL RATE
MODERNIZATION PLAN; CASE NO. PAC-E-22-15.**

On October 20, 2022, PacifiCorp d/b/a Rocky Mountain Power (“Company”), applied to the Commission requesting authorization to implement a residential rate modernization plan over five years (“Residential Rate Modernization Plan”). Application at 1.

On November 30, 2022, the Commission issued a Notice of Application, Notice of Suspension of Proposed Effective Date, and Notice of Intervention Deadline. Order No. 35615. Clean Energy Opportunities for Idaho (“CEO”), Idaho Conservation League (“ICL”), and the NW Energy Coalition (“NWECC”) intervened. Order Nos. 35634 and 35655.

On January 10, 2023, Commission Staff (“Staff”) provided the Company and all Intervenors with a proposed schedule for written testimony. Staff proposed:

- March 14, 2023, Public workshop
- April 11, 2023, Public Comment deadline
- April 18, 2023, Customer Hearing
- April 25, 2023, Company Reply deadline


The Company and all Intervenors were notified about Staff’s proposed schedule, and no party objected to the proposed dates.

STAFF RECOMMENDATION

Staff recommends the Commission issue a Scheduling Order setting a March 14, 2023, public workshop at 6:00 pm and an April 18, 2023, Customer Hearing at 6:00 pm. Additionally, Staff recommends the Commission order include a Notice of Modified Procedure setting an April 11, 2023, public comment deadline and an April 25, 2023, Company reply deadline.
