On February 7, 2025, Rocky Mountain Power, a division of PacifiCorp ("Company") filed an application ("Application") with the Idaho Public Utilities Commission ("Commission") requesting an order approving the Company's proposed changes to its onsite self-generation Electric Service Schedule 136 ("Schedule 136") tariff and approving the Company's proposed export credit rate methodology. Application at 1.

On February 27, 2025, the Commission issued a Notice of Application and Notice of Intervention Deadline. Order No. 36482. No parties intervened.
