
1. On September 28, 2023, the Appellants submitted a notice of appeal against Order 35904 of the Idaho Public Service Commission (“Commission”). Subsequently, on December 13, 2023, the Appellants lodged an objection to the proposed agency record for this appeal. Specifically, they requested the exclusion of a public comment, the inclusion of the Clerk’s Certificate of Service (dated November 20, 2023) referenced in the table of contents, a revision to the table on contents pertaining to the filing date for the motion of reconsideration, and the addition

of an email and associated attachments submitted to the Commission by the Appellants on September 27, 2023.

2. The Company has assessed the objection and believes that the requested relief would not disadvantage it during the appeal. As such, it does not contest the Appellant's objection submitted on December 13, 2023.
