Again regarding Avista's request for another rate increase, and also in response to Gene Fadness of the Idaho PUC and his letter to the editor printed 4-16-09, I will try to make my letter to the editor of 4-2-09 a little clearer. The electric rate last Sept. 2008 was .0633 per KWH. In Nov. 2008, the rate rose to .0768 per KWH, an increase of 21.3% over the Sept. rate. Dec., Jan. and Feb. rates averaged .0802 per KWH, making for a total increase of 26.7% over the Sept. rate. These KWH rates were taken right from our monthly Avista bills. Now to repeat, if Avista's request for another increase is granted, customers' new rates will end up being 37% more than what they were in Sept. 2008. If anyone thinks this new increase is a bit much, they can let the Idaho PUC know how they feel, and, or, they can attend the PUC workshop scheduled for 5-12-09 at 7 PM at the Community Hall in Sandpoint at 204 S. First Ave, and voice their concerns.
