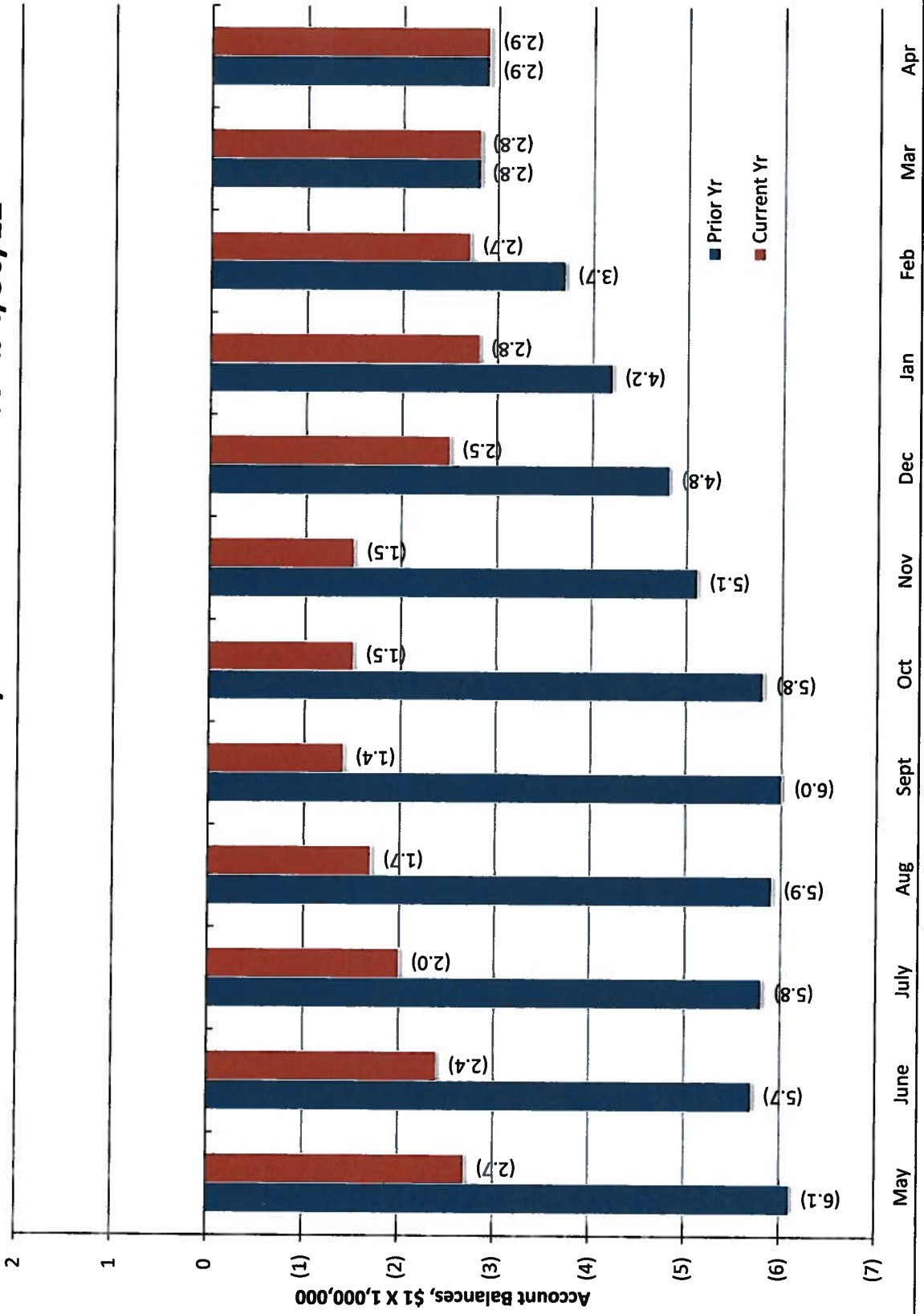
Note 1 - Amortization is recorded in Account 191000 based on Thirteenth Revision Sheet 155, effective 10/1/11. This Sheet decreases the rates of firm Schedules 101 and 111 by \$.02885 per therm in all blocks and decrease the rates of Schedule 131 by \$.03314 per therm.

Note 2 - Seventeenth Revision Sheet 150, effective 3/1/12, governs the accounting of deferred gas cost differences. These differences are recorded monthly to Account 191010 and are based on the weighted average cost of gas, including a gross revenue factor, per therm as follows:

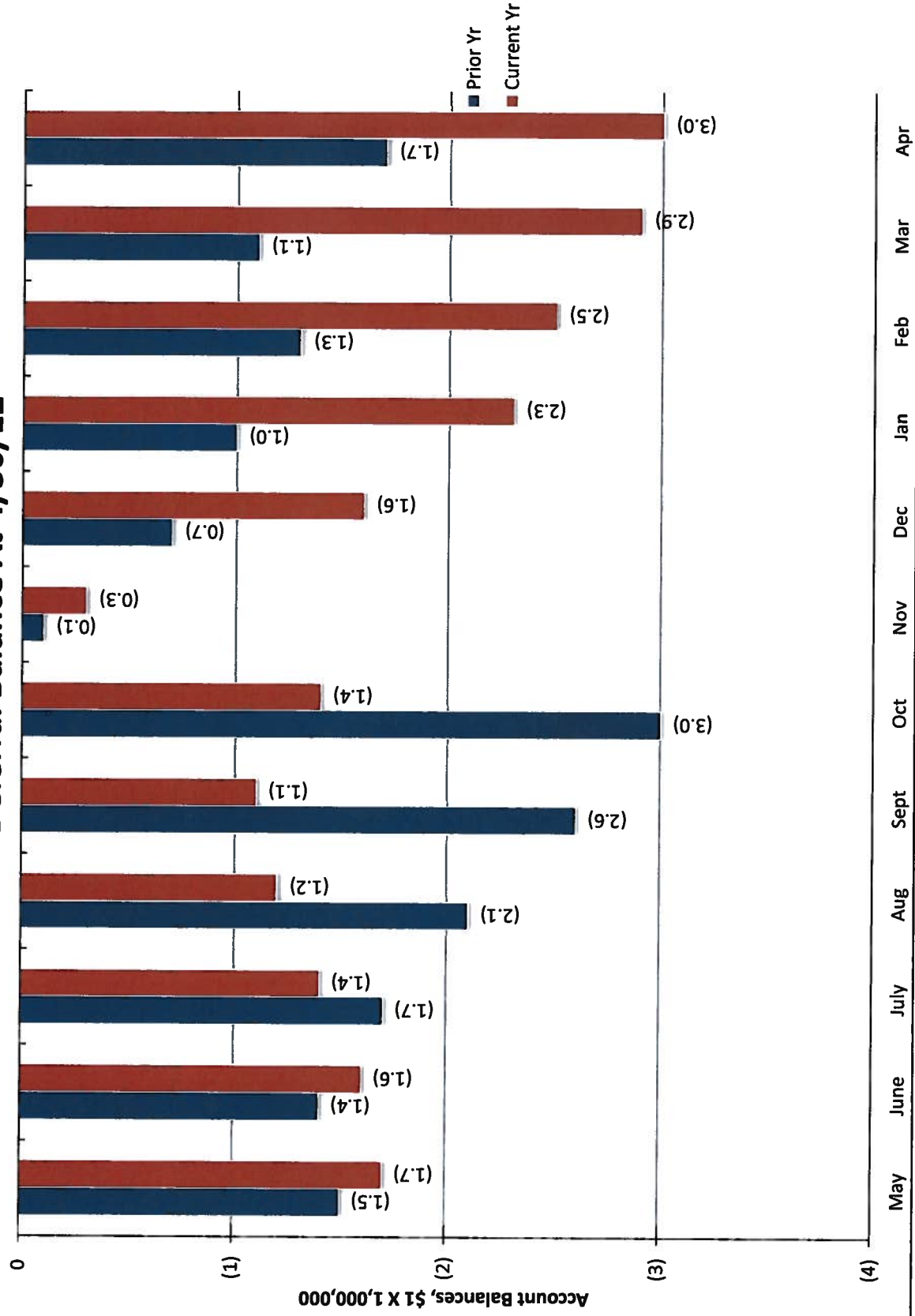
