On October 11, 2012, Avista Corporation dba Avista Utilities applied to the Commission for authority to increase its electric base rates by \$11.4 million (4.6%) and its natural gas base rates by \$4.6 million (7.2%). Application at 1. The Company says its request would increase the average residential customer's (1) electric bill by \$4.20 (5.3%); and (2) natural gas bill by \$4.12 (7.8%). *Id.* at 11. The Company proposes that the new rates take effect on April 1, 2013. *See* Amendment to Application.

On October 30, 2012, the Commission issued a Notice of Application and Notice of Intervention Deadline. Order No. 32671. The following parties intervened in the case: Idaho Forest Group, LLC; Clearwater Paper Corporation; Community Action Partnership Association of Idaho; Idaho Conservation League; and Snake River Alliance. The Commission issued a Notice of Schedule on December 4, 2013, that set deadlines for the parties to file testimony and exhibits, and tentatively scheduled an April 8-12, 2013 technical hearing. The Commission also suspended the Company's proposed April 1, 2013, effective date for a period of 30 days plus 5 months. *See* Order No. 32689.
