This is with reference to that certain Agreement and Plan of Merger, dated as of July 19, 2017 (the "<u>Merger Agreement</u>"), by and among Hydro One Limited, a corporation organized under the laws of the Province of Ontario ("<u>Parent</u>"), Olympus Holding Corp., a Delaware corporation ("<u>US Parent</u>"), Olympus Corp., a Washington corporation ("<u>Merger Sub</u>"), and Avista Corporation, a Washington corporation (the "<u>Company</u>"). Capitalized terms used but not defined herein shall have the meanings ascribed to them in the Merger Agreement.
