II. RESPONSE TO REPORT AND MOTION

6 The status report provides that Hydro One announced the 10 members of its new board on 7 August 14, 2018. Report and Motion at 2. This was as expected from the information previously 8

provided to the Commission. See *Idaho Letter* at 2 (July 18, 2018) ("Hydro One has committed to

completing the transition process to a new board of directors by August 15, 2018").

It is clear that the new board had not been briefed, let alone provided any direction, on the Avista merger. In response to a question on this topic ("[H]ave you had a chance to socialize the Avista acquisition with the new board? In other words how do we know that this new board is in alignment with [the] Avista acquisition?"), Paul Dobson, Hydro One's Chief Financial Officer and acting CEO responded at the company's August 14 briefing: "So we have not sat down with the new board and gone through the Avista transaction." *Briefing Transcript*.

The status report also provides that Hydro One has not selected a new CEO to replace Mayo Schmidt who retired on July 11, 2018, the same day that Hydro One's Chief Financial Officer, Paul Dobson, was named Hydro One's acting CEO. Report and Motion at 2-3. The information about the interim CEO was already known to the Commission at the time that it issued its Order on July 20. See Idaho Letter at 2 (July 18, 2018) ("Paul Dobson, Hydro One's chief financial officer, has been appointed as acting chief executive officer until such time as the replacement board of directors, once constituted, can appoint a new chief executive officer").
