Mayo Schmidt, CEO of Hydro One, stated "There are quite a number of organizations of the same size and complexity of Avista in the arena that, as we think about over the course of the next years, there's some potential," he said in an interview at Bloomberg's Toronto office...The utility has faced criticism around high electricity prices and executive compensation since the Ontario Liberal government sold a 13.6-per-cent stake of its shares through the initial public offering. The province now holds about 45 per cent of Hydro One after two subsequent sales and doesn't intend to go below 40 per cent."

- 2. Hydro One, should it acquire Avista, will compromise Idaho's control of it's critical infrastructure. The merger has the potential to put in jeopardy the State's economy because power resources are the foundation of commerce. The IPUC Commissioners have an unbearable personal burden in deciding this case.
