On August 29, 2025, Avista Corporation dba Avista Utilities ("Company") applied for authority to revise tariff Schedule 195—Optional Renewable Gas ("Application"). The Company proposes modifications to the voluntary Renewable Natural Gas ("RNG") program that provides customers an opportunity to purchase RNG as part of their regular monthly service, which would increase the therms provided per \$5.00 block from 1.5 therms to 2 therms. The Company requests a January 1, 2026, effective date.

The Commission now issues this notice of the Company's Application and of Modified Procedure establishing deadlines for interested parties to comment on the Application and for the Company to reply.

BACKGROUND

In Order No. 35520, the Commission approved the Company's request to implement Schedule 195 offering a voluntary RNG program in Idaho. The tariff sheets approved in Order No. 35549 provide customers an opportunity to purchase blocks of RNG in addition to the customer's regular natural gas charges to help offset their carbon emissions. Each block includes environmental attributes represented by the equivalent to 1.5 therms of RNG for \$5.00 per block.

NOTICE OF APPLICATION

YOU ARE HEREBY NOTIFIED that the Company states that after its original contract to acquire RNG for its program expired in December 2024, the Company was able to secure a more favorable price in its new RNG supplier agreement. Application at 2. The Company proposes to pass the savings from the new agreement onto customers participating in the RNG program. *Id*.

YOU ARE FURTHER NOTIFIED that the Company believes preserving the current price of \$5.00 per block would be easy for customers to understand by maintaining a consistent bill impact. *Id.* at 3.

YOU ARE FURTHER NOTIFIED that the Application is available for public inspection during regular business hours at the Commission's office. The Application is also available on the Commission's website at www.puc.idaho.gov. Click on the "NATURAL GAS" icon, select "Open Cases," and click on the case number as shown on the front of this document.

YOU ARE FURTHER NOTIFIED that all proceedings in this case will be held pursuant to the Commission's jurisdiction under Title 61 of the Idaho Code, and that all proceedings in this matter will be conducted pursuant to the Commission's Rules of Procedure, IDAPA 31.01.01.000 *et seq.*
