

All other current employees must meet the new eligibility criteria of age 60 and 10 years of continuous service at the time they retire. These employees will be eligible for a specified company funded Retiree Reimbursement Account. Employees at Intermountain hired after December 31, 2009, will not be eligible for retiree medical benefits.

The Company also has unfunded, nonqualified benefit plans for certain executive officers. Intermountain's plan provides for defined benefit payments following the employee's retirement until death for a minimum of a 20-year period or to their beneficiaries upon pre-retirement death for a 10-year period equal to twice the benefit the participant was entitled to before death. The Company had investments of \$9.8 million at December 31, 2010, consisting of equity securities of \$1.8 million, life insurance carried on plan participants (payable upon the employee's death) of \$6.4 million and other investments of \$1.6 million, which the Company anticipates using to satisfy obligations under these plans. The Company's net periodic benefit cost for these plans was \$1.3 million and \$1.3 million in 2010 and 2009, respectively. The total projected benefit obligation for these plans was \$13.6 million and \$12.9 million at December 31, 2010 and 2009, respectively. The accumulated benefit obligation for these plans was \$13.5 million and \$12.7 million at December 31, 2010 and 2009, respectively. A discount rate of 5.0 percent and 5.75 percent at December 31, 2010 and 2009, respectively, was used to determine benefit obligations. A discount rate of 5.75 percent and 6.25 percent at December 31, 2010 and 2009, respectively, and a rate of compensation increase of 4.00 percent at both December 31, 2010 and December 31, 2009, was used to determine net periodic benefit cost.

The amount of benefit payments for the unfunded, nonqualified benefit plans, as appropriate, are expected to aggregate \$1.0 million in 2011; \$1.0 million in 2012; \$1.0 million in 2013; \$923,000 in 2014; \$917,000 in 2015; and \$5.2 million for the years 2016 through 2020.

The Company sponsors various defined contribution plans for eligible employees. Costs incurred by the Company under these plans were \$839,000 and \$2.4 million in 2010 and 2009, respectively.
