On December 20, 2024, Intermountain Gas Company ("Company") filed an application ("Application") with the Idaho Public Utilities Commission ("Commission") for an order designating \$3,846,358 of 2023 energy efficiency expenditures as prudently incurred. The Company's Application included its 2023 Energy Efficiency Annual Report, an Evaluation, Measurement, and Verification ("EM&V") Study with a billing analysis, and proposed revised Rate Schedule EE-RS.

On February 3, 2025, the Commission issued a Notice of Application and Notice of Intervention Deadline. Order No. 36455. The Commission granted intervention to the City of Boise City. Order No. 36487.
