On March 24, 2024, the Commission issued a Notice of Application and Notice of Modified Procedure, Notice of Virtual Public Hearing, and Notice of Telephonic Customer Hearing. Order No. 36124. Order No. 36124 set a telephonic customer hearing for April 10, 2024, at 11:00 A.M. (MST).

At the Commission’s April 2, 2024, Decision Meeting, the Commission addressed a recommendation to vacate the telephonic customer hearing currently set in this case and replace it with an in-person customer hearing on the same date.



**ORDER**


IT IS HEREBY ORDERED that the public telephonic customer hearing scheduled for April 10, 2024, at 11:00 A.M. is vacated.
