#### REQUEST FOR REGULATORY TAKING ANALYSIS

### 1. Background Information.

This form satisfies the written request requirement for a regulatory taking analysis from a state agency pursuant to Idaho Code § 67-8003(2). A regulatory taking analysis is considered public information. Such an analysis is to be performed in accordance with the checklist established by the Attorney General of the State of Idaho pursuant to Idaho Code § 67-8003(1). Both *Stoehr v.
