On March 29, 2024, Fybercom LLC dba Fybercom ("Company") applied to the Idaho Public Utilities Commission ("Commission") requesting the issuance of a Certificate of Public Convenience and Necessity ("CPCN") authorizing the Company to offer local telecommunication exchange services in Idaho ("Application"). On May 6, 2024, the Company filed a Certificate of Existence with the Idaho Secretary of State. On May 14, 2024, the Company submitted an amended application ("Amended Application") that further conformed with the Commission's requirements for the issuance of a CPCN.

The Commission now issues this Notice of Application and sets deadlines for interested persons to comment on the Application and for the Company to reply.

NOTICE OF APPLICATION

YOU ARE HEREBY NOTIFIED that the Company is an Idaho LLC which intends to offer resale services "pursuant to a resale arrangement that will be entered into between Fybercom and the Idaho ILEC CenturyLink and/or its affiliates following action on this Amended Application by the Commission." Amended Application at 3. The Company stated that it also intends to offer exchange access and broadband services.

YOU ARE FURTHER NOTIFIED that the Company outlined how much of it was owned by certain individual owners and entities by providing a list with each owners' percentage/interest in the Company listed. The Company explained that it owns two Idaho subsidiaries: Omega Networks LLC and SkyNet LLC. The Company also provided a list of Company's officers and managers.

YOU ARE FURTHER NOTIFIED that if no written comments or protests are received within the time limit set, the Commission will consider this matter on its merits and enter its Order without a formal hearing. If written comments are received within the time limit set, the Commission will consider them and, in its discretion, may set the same for formal hearing.

ORDER

IT IS HEREBY ORDERED that the Company's request for a CPCN be processed by Modified Procedure. Persons interested in submitting written comments must do so within 28 days of the service date of this Order. The Company must file any reply comments within 35 days of the service date of this Order.

IT IS FURTHER ORDERED that parties comply with Order No. 35375, issued April 21, 2022. Generally, all pleadings should be filed with the Commission electronically and will be deemed timely filed when received by the Commission Secretary. *See* Rule 14.02. Service between parties should continue to be accomplished electronically when possible. However, voluminous discovery-related documents may be filed and served on CD-ROM or a USB flash drive.
