## AFFIDAVIT OF BUSINESS OR CORPORATE OFFICER

## FILING DEADLINES

By July 1, 2020: All ETCs requesting federal high-cost or low-income support from the Universal Service Administrative Company (USAC) must confirm with the Commission that they have filed with USAC and the FCC, FCC Form 481 (47 C.F.R. §§ 54.313 & 54.422) and must file with the IPUC a Signed Affidavit (see note). IPUC Filing methods:

By September 1, 2020: All other ETCs who do not receive federal high cost funds must notify the Commission upon filing Form 481 and file the affidavit (minus item 5) with the Commission Secretary. This satisfied the PUC annual report requirement for ETCs. See Order No. 29841.

Notes:

- When filing Form 481 with the FCC, clearly reference WC Docket Nos. 10-90 and 11-42 (as appropriate).
- The FCC does not require the signed affidavit.
- Before October 1, 2020: The PUC Staff will submit the Annual Use Certification Letter (47 C.F.R. § 54.314) to USAC and the FCC on behalf of Idaho ETCs who receive federal highcost support.
