MCImetro Access Transmission Services Corp. d/b/a Verizon Access Transmission Services ("MCImetro Corp.") respectfully notifies the Idaho Public Utilities Commission ("Commission") of its name change to MCImetro Access Transmission Services LLC d/b/a Verizon Access Transmission Services ("MCImetro LLC") as the result of its conversion from a corporation to a limited liability company on July 31, 2021. MCImetro Corp. has registered the new name with the Idaho Secretary of State and the corresponding registration document(s) are attached. MCImetro Corp. respectfully requests the Commission to amend its Certificate of Convenience and Necessity, Certificate No. 337, to reflect this change in corporate name.

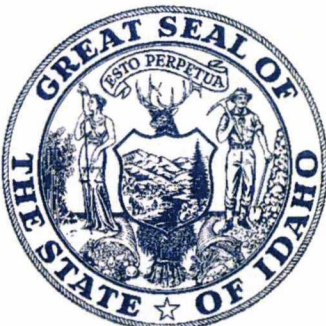
