YOU ARE FURTHER NOTIFIED that Altice USA, Inc. was among the winning bidders in the recent Rural Digital Opportunity Fund ("RDOF") Auction 904, and Altice USA, Inc. assigned its winning bids in Idaho to Suddenlink on December 22, 2020.

YOU ARE FURTHER NOTIFIED that Suddenlink seeks to be designated an ETC in the Idaho census blocks where its RDOF funding may be used. Suddenlink asserts it meets all federal and state requirements for designation as an ETC and that designating Suddenlink as an ETC is in the public interest.

YOU ARE FURTHER NOTIFIED that the Commission must designate a telecommunications carrier as an ETC before the telecommunications carrier can receive RDOF support. Suddenlink asks that the Commission approve its Application and designate Suddenlink an ETC by June 6, 2021.
