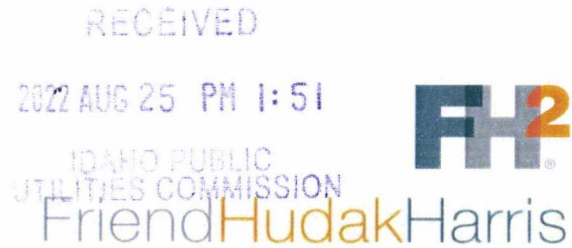

On June 14, 2022 Telrite filed an Application for Designation as an Eligible Telecommunications Carrier (the "Application") throughout the State of Idaho. On July 1, 2022 Telrite filed a Supplement to the Application to meet certain requirements set forth in Order No. 35126 regarding the provision of service in Tribal areas.
