COMPLIANCE FILING – TARIFF


As part of the Idaho Public Utilities Commission Order No. 32324, the Commission directed Brian Water Corporation to submit revised tariffs in compliance with the rates and charges identified in this Order. The rates and charges authorized by the Order shall become effective for service rendered on or after August 12, 2011.

Staff reviewed the tariffs submitted by the Company on August 11, 2011, to ensure that the language and rates reflect Commission directives as stated in Order No. 32324. The tariffs include Rate Schedule No.1, Recurring Charges and Rate Schedule No. 2, Non-Recurring Charges. This tariff replaces the current tariff on file.

Staff confirms that the new language and rates of Schedule No. 1, Recurring Charges and Rate Schedule No. 2, Non-Recurring Charges, comport with Commission Order No. 32324. Staff recommends approval of the tariffs. See attachments.

NON-RECURRING CHARGES

LATE PAYMENT CHARGE

One percent (1 %) per month of the unpaid balance at the time of the next monthly billing statement.

RECONNECTION FEE - \$12.50

Reconnection Charge: A reconnection charge will be assessed to any customer who has been involuntarily disconnected by the Company for any reason allowed by the UCRR. Charges do not apply when a customer was involuntarily disconnected for the convenience of the Company.
