On March 1, 2024, Capitol Water Corporation, (“Company”) applied to the Idaho Public Utilities Commission (“Commission”) requesting authorization to increase its rates and charges for water service.

On December 19, 2024, the Commission issued Order No. 36427 approving an annual revenue requirement for the Company of \$823,592. The approved revenue requirement was based on adjustments and calculations summarized in Order No. 36427. The Commission directed the Company to submit conforming tariffs and schedules in conformance to Order No. 36427.

On January 10, 2025, the Company filed conforming tariffs and schedules reflecting the rates approved in Order No. 36427. Commission Staff (“Staff”) reviewed the Company’s tariffs and schedules and confirmed the corrected filing conforms to Order No. 36427. Staff reviewed the filing and, at the Commission’s January 21, 2025, decision meeting, recommended that the Commission accept the filing with an effective date of January 1, 2025.

COMMISSION FINDINGS AND DECISION

The Commission has jurisdiction over the Company’s Application and the issues in this case under Title 61 of the Idaho Code including *Idaho Code* §§ 61-301 through 303. The Commission is empowered to investigate rates, charges, rules, regulations, practices, and contracts of all public utilities and to determine whether they are just, reasonable, preferential, discriminatory, or in violation of any provisions of law, and to fix the same by order. *Idaho Code* §§ 61-501 through 503.

Having reviewed the record and the Company’s submission, the Commission finds that the Company has complied with Order No. 36427.


ORDER
