On March 22, 2012, Country Club Hill Utilities, Inc. ("CCHU" or "Company") filed an Application requesting authority to increase its rates and charges for water service. The Company is seeking Commission authorization for an approximately 32% increase in its rates for water service.

On April 12, 2012, the Commission issued a Notice of Application and suspended the Company's Application for a period of 30 days plus 5 months pursuant to *Idaho Code §* 61-622. *See* Order No. 32518. Subsequently, Commission Staff ("Staff") submitted requests for production of documents and information pertaining to the Company's Application and the Company filed responses to the Staff's production requests.
