DESCRIPTION FOR STATE OF IDAHO- DRY CREEK CEMETERY DISTRICT

A parcel of land being a portion of the SW1/4 of Section 11, T.4N., R.1E., B.M., a portion of Lot 3, Block 1 of Hidden Hollow Subdivision as filed in Book 53 of Plats at Page 4784 records of Ada County, Idaho located in the SE1/4 of Section 11, T.4N., R.1E., B.M., and a portion of Lots 2 and 3 of Roberts and Hill Subdivision as recorded in Book 4 of Plats at page 159 records of Ada County, Idaho and located in the NW1/4 of the NW1/4 of Section 14 T.4N., R.1E., B.M., Ada County, Idaho, more particularly described as follows:
