

SUMMARY OF COMMENTS OF EAGLE WATER COMPANY, INC.

COMES NOW, EAGLE WATER COMPANY ("Eagle Water"), and files the following SUMMARY of its previous Comments regarding the Idaho Public Utilities Commission's Proposed Order granting service of Covenant Hill Subdivision to United Water of Idaho, Inc.

SUMMARY OF COMMENTS

First of all, Eagle Water would like to begin by thanking the Commission for granting Eagle Water's request that the Commission delay its decision regarding this matter until its Decision Meeting on November 28, 2005.

Given the criticalness of the decision that is before the Commission to Eagle Water's overall master plan for providing service within its existing service area, Eagle Water believes the following summary of its Comments and position regarding this

SUMMARY OF COMMENTS OF EAGLE WATER COMPANY - 1 matter may assist the Commission in reaching a fair and equitable resolution of this matter that will, ultimately benefit all of Eagle Waters customers.

- 1. Ninety percent of the proposed Covenant Hill Subdivision is located in Eagle Water's service area.
- 2. Eagle Water is ready, willing and able to serve the proposed Covenant Hill Subdivision. *See* Exhibit 5, Letter from James M. Rees, P.E., MTC, Inc. to R. Tomlinson, P.E. (Hillview Development Corporation engineering consultant), attached.
- 3. This service will be provided from Eagle Water's existing 12-inch mainline located on Floating Feather Road.
- 4. No additional easements are necessary to implement this service connection to the proposed subdivision.
- 5. Eagle Water currently has sufficient fire flow pressure and potable water supply to serve the proposed Covenant Hill Subdivision.
- 6. DEQ has lifted its blanket moratorium on new service connections to Eagle Water's system, as it pertained to the proposed Covenant Hill Subdivision. *See* Exhibit 6, attached.
- 7. The only condition to DEQ's acceptance of Eagle Water's "Will Serve" letter for Covenant Hill is the Commission's approval of the timeline Eagle Water has committed to for constructing a 12-inch mainline loop from its Well No. 6 to the mainline serving the Covenant Hill. *See* Exhibit 6 (Letter from R. DeShazo to M. Marchus, Idaho Department pf Environmental Quality, dated November 18, 2005).
- 8. Eagle Water has committed to having the 12-inch mainline loop in service on or before April 1, 2006. *Id*.
- 9. In the unlikely event that Eagle Water does not meet this deadline, it will relinquish the Covenant Hill portion of its service area to United Water.

10. United Water has already stated that it can serve Covenant Hill in the event that Eagle Water cannot. Thus, there is no risk to Hillview Development.

11. The potential harm to Eagle Water, however, and its customers, of not being able to serve Covenant Hill Subdivision is profound. As Eagle Water has previously explained, the property upon which the subdivision is proposed (the former Calhoun Property) has been in Eagle Water's service area for many years and has long been identified as the most cost-effective route for the 12-inch mainline loop. It would be prohibitively expensive to force Eagle Water to route its loop through the Downing Downs subdivision as suggested by Mr. Merkle, of Hillview Development – a cost that would ultimately be borne by Eagle Water's customers. Such an investment would not be prudent.

CONCLUSION


Eagle Water respectfully requests that the Commission allow it to serve the Covenant Hill Subdivision and, consequently complete the proposed 12-inch mainline loop from its Well No. 6 to its 12-inch mainline on Floating Feather Road. This loop will benefit all Eagle Water customers.

The Covenant Hill Subdivision water system is serviceable by Eagle Water Company under its present tariffs, rules and regulations as filed with the Idaho Public Utilities Commission.

The AutoCad plans have been reviewed and are approved by MTC Engineers, Eagle Water Company and appear to comply with the standards for construction on file with the Idaho Department Of Environmental Quality.

MTC Engineers and Eagle Water Company will have to inspect and approve all construction and testing. Dear Monty:

As we have discussed, Eagle Water Company, Inc. ("Eagle Water") is currently able to deliver sufficient water supply and pressure to meet fire flow requirements for the proposed Covenant Hills Subdivision ("Covenant Hills"); however, Eagle Water desires to route a 12-inch mainline from its Well No. 6 through Covenant Hills to tie that well into this portion of its system, thereby improving pressure elsewhere in its system.

Although Hillview Development maintains that Eagle Water can route its 12-inch mainline loop through the adjacent Downing Downs subdivision, that is not a viable, cost-effective alternative. Unlike the essentially unimproved ground that Eagle Water has identified for routing its mainline loop, the Downing Downs subdivision is fully developed with streets, existing structures, and mature landscaping. It would be cost-prohibitive for Eagle Water to utilize this route and that excessive cost would ultimately have to be passed on to consumers.

Consequently Eagle Water requests that the Idaho Department of Environmental Quality ("DEQ") provide Eagle Water with a letter allowing it to proceed to service the subdivision known as Covenant Hills Subdivision ("Covenant Hills"). Your letter would allow the developer to begin construction of the subdivision immediately.

Eagle Water understands that DEQ's letter authorizing it to provide service to Covenant Hills would be conditioned on the following:

- 1. That Eagle Water continue working with the two landowners (Greg Holmes and Jim Choat) south of Covenant Hills and the Hereford Subdivision Homeowners Association to obtain a permanent easement to connect Eagle Water's existing 12-inch water main stub on the Holmes property to the new Covenant Hills mainline on or before February 16, 2006.
- 2. That MTC Engineering, Inc. provide DEQ working drawings, plans and specifications for the extension of the 12-inch mainline to Covenant Hills by January 10th, 2006.
- 3. That Eagle Water construct and connect the 12-inch mainline from its Well No. 6 to Covenant Hills on or before April 1, 2006.
