Please accept this letter as notice that, as of August 1, 2020, Falls Water Co., Inc. ("Falls Water") has been made a direct subsidiary of NW Natural Water of Idaho, LLC ("NW Natural Water of Idaho"), which is itself a subsidiary of NW Natural Water Company, LLC ("NW Natural Water"). Previously, Falls Water was a direct subsidiary of NW Natural Water.

This change provides consistency in the overall corporate structure by placing Falls Water alongside NW Natural Water of Idaho's other Idaho water company subsidiary, Gem State Water Company, LLC. Falls Water provided notice to the Commission of this intended reorganization in its Application for Approval of Acquisition of the Assets of Morning View Water Company, Case No. FLS-W-20-04 (July 31, 2020) at p.2 n.1.
