On July 21, 2022, Gem State Water Company, LLC ("Company") applied to the Idaho Public Utilities Commission ("Commission") for authorization to increase its rates and charges for water service. The Company requested its Application be processed by Modified Procedure and that any changes to its rates and charges be effective for bills rendered on or after September 1, 2022.

On September 6, 2022, the Commission issued a Notice of Application, a Notice of Intervention Deadline, and a Notice of Suspension of the Proposed Effective Date. Order No. 35498. There were no intervenors in this case. On October 6, 2022, the Commission issued a Notice of Modified Procedure. Order No. 35548.

On November 1, 2022, the Commission issued a Notice of Public Workshop setting a November 15, 2022, public workshop date. Order No. 35580

With this Order, the Commission provides a Notice of Public Customer Hearing and Notice of Extension of the Public Comment Deadline.
